

LIONS LEGEND SIGNED MEMORABILIA COMPETITION – TERMS & CONDITIONS

PLEASE NOTE

Prizes can only be posted to registered addresses in the United Kingdom or Republic of Ireland and will be sent by standard post. Given the package size, someone will need to be at the address to take receipt.
